**IMPORTANT:** The strongest nominations provide clear information about how the nominee meets each of the award criteria, provides specific examples, and includes testimonials or quotes from people that can provide firsthand information about the influence or impact of the person or program being nominated.

A selection committee appointed by the CHAC Governing Council will choose the recipient(s).

### Deadline for nominations: February 29, 2024

**NOTE: Previous CHAC National Award recipients, current members of the CHAC Governing Council and staff of CHAC are not eligible to be nominated.**

#### REQUIRED INFORMATION: LIFETIME ACHIEVEMENT AWARD

- ✓ Name of nominee, employer, position title, and contact information
- ✓ Category of Lifetime Achievement nomination: honouring a direct caregiver; honouring a leader; honouring a board member
- ✓ Name of person submitting the nomination, and their contact information
- ✓ Summary of the years of experience and type of experience the nominee has with their current organization and the Catholic health ministry
- ✓ Description of how the person being nominated exemplifies the following criteria:
  - Inspired and mentored a significant number of others in Catholic health
  - Accomplishments that have helped strengthen the Catholic health ministry
  - Recognized as a respected leader in Catholic health, and her/his community and possibly beyond
  - Demonstrates a commitment to the ministry by:
    - Promoting and defending human dignity
    - Attending to the whole person
    - Caring for persons who are marginalized and vulnerable
    - Promoting the common good
    - Acting on behalf of justice
    - Stewarding resources wisely
    - Acting in communion with Catholic social teachings

**REQUIRED INFORMATION: LEADERS OF TOMORROW AWARD**

- ✓ Name of nominee, employer, position title, and contact information
- ✓ Summary of the years of experience and type of experience the nominee has with their current organization and the Catholic health ministry
- ✓ Name of person submitting the nomination, and their contact information
- ✓ Description of how the person being nominated exemplifies the following criteria:
  - Provides outstanding leadership within her/his organization
  - Likely to assume leadership positions within Catholic health that have additional and broader responsibility
  - Confirmation that the nominee is mid-career, has worked with a health organization with Catholic identity for at least five years, and is expected to advance in their career over the next 10 years.
  - Potential to provide national leadership in the future
  - Specific accomplishments that have helped strengthen the Catholic health ministry
  - Demonstrates a commitment to the ministry by:
    - Promoting and defending human dignity
    - Attending to the whole person
    - Caring for persons who are marginalized and vulnerable
    - Promoting the common good
    - Acting on behalf of justice
    - Stewarding resources wisely
    - Acting in communion with Catholic social teachings

- ✓ Program name and name of organization that has governance responsibility for the program
- ✓ Information about when the program was established and the services it provides
- ✓ Contact person for the program being nominated and her/his contact information
- ✓ Name of person submitting the nomination, and her/his contact information
- ✓ Description of how the program being nominated exemplifies the following criteria:
  - Displays innovation and leadership by providing service to people who are vulnerable and marginalized in the spirit of the ministry of the healing ministry of Jesus
  - Acknowledged as innovative
  - Demonstrates a commitment to the ministry by:
    - Promoting and defending human dignity
    - Attending to the whole person
    - Caring for persons who are marginalized and vulnerable
    - Promoting the common good
    - Acting on behalf of justice
    - Stewarding resources wisely
    - Acting in communion with Catholic social teachings
  - Demonstrates a prophetic witness of the ministry by:
    - Exemplifying the Catholic health mission of the organization
    - Demonstrating the importance of spirituality and of grounding Gospel values in the services the organization provides
    - Demonstrating partnership and collaboration with other organizations within the local community
    - Reaching beyond the institution and beyond traditional modes of service delivery.
